#### From Our President

Welcome members to this issue of the *Climate*. As I am typing this, the Phillies have won the World Series and are going to parade down Broad Street. Yeah Phillies!

We look forward to our next dinner meeting which will take place on November 13 at Dave and Buster's. The speaker will be Ralph DiPietro of Philadelphia Licenses and Inspections office. He will discuss Philadelphia's permit review process and recent changes to the code. Afterwards will be the first meeting of our chapter for Young Engineers in ASHRAE, hosted by Ashley Kenyon. We hope you can make it.

You can also look forward to our December breakfast meeting where the topic will be "Condenser Water Heat Recovery" by ASHRAE Distinguished Lecturer Julian R. deBullet.

Since Green design and construction has been a very topical subject, I wanted to highlight an upcoming program from Society. I want to share with you an email I received from Terry Townsend, past president of ASHRAE who spoke at our January dinner meeting, where he talks about the new High Performance Buildings Certification Program. I think he states it best so I will quote his message:

I expect the HPB Certification Program to become a factor in achieving the objective that ASHRAE can convince building owners that it is to their benefit to use engineers who have been certified to achieve current and future energy goals in construction and operation.

The HPB certification program is intended to become a second and third tier training sequence for those who are LEED-AP - the USGBC was a partner in developing this program and will continue to assist in upgrading the training and exam processes.

Also, the upcoming Advanced Energy Guide for Existing Building will initially focus on business owners and decision makers - BOMA, USGBC, GSA and IESNA are collaborating in this effort.

Finally, the Building Performance Metrics Steering Committee that I chair has four Project Committees that will be providing special publications, engineering tools, web-based energy benchmarks and a database for high-performance buildings that integrate the Performance Metrics Protocols that will eventually become a Guideline for the global HVAC&R industry.

Finally, a Building Energy Labeling initiative was approved by the ASHRAE Board of Directors in Salt Lake City that will be developed in collaboration with EPA and DOE and will contain both asset ratings and building performance ratings (somewhat similar to the EU directives). ASHRAE will be developing a certification program for the participation in this national building rating effort.

The combined effect of these programs, initiatives and efforts will beneficial in educating owners that engineers are not "necessary evils and problem makers" but rather are "solutions providers and 'bottom line' improvers" for businesses.

#### ASHRAE Research – Researching Today to Change Tomorrow

I realize that some may see this as the chapter asking for money again, but I feel it is important to pass on this information to illustrate how ASHRAE responsibly uses the funds collected each year.

When you donate to ASHRAE Research, your money goes a long way. 100% of the donation goes to research projects. Society raises funds from other sources to cover the administrative expenses. Additionally, all funds raised are matched dollar-for-dollar from proceeds of the winter AHR Exposition. \$50=\$100, \$250=\$500, \$1,000=\$2,000...

So what are we doing at the chapter level to support this effort? For starters, the chapter officers and Me (the RP Chair) all donate at the honor roll level (\$100 or more). We also hold 50/50 raffles at the monthly meetings. Half of the money raised goes to research and the other half goes to the holder of the winning ticket. At the September Meeting the pot was \$710 and the winner contributed his half back to Research. Also, we will be organizing a calling campaign this year. The research promotion committee takes to the phones to find chapter members willing to support the cause. For the 07-08 Research Promotion campaign our chapter raised a total of \$20,895, this year our goal has been set at \$30,000, we have collected \$3,530 to date so there is a long way to go. Please be generous when asked by a committee member to contribute to this worthy cause.

So what do we get back from ASHRAE Research? Lots! Most notable are updated and newly developed standards, updates to the handbooks and the papers and reports published in ASHRAE Transactions. What most people do not know about is the money that comes back into our chapter/state/region to complete research projects. In 2007, approximately \$30,000 was awarded to projects in our chapter area, approx. \$519,000 to projects in PA, and approx. \$720,000 to projects in Region III. As you can see, the amount of money coming back to our local economies is much greater than what we put into ASHRAE Research.

Finally, donations to ASHRAE Research are tax deductible. Depending on how the federal government solves the mortgage/financial crisis, everyone maybe seeing higher taxes. You can control where some of that money goes by giving to ASHRAE Research.

The Chapter Technology Transfer Committee is asking for applications for the 2009 Chapter Level competition to be submitted by March 6, 2009. Awards for the Chapter Level competition will be given out during the May 14, 2009 Chapter Meeting for the following categories:

- Health Care Facilities, New and Existing
- Industrial Facilities or Processes, New and Existing
- Public Assembly Facilities, New and Existing

Winners of the Society Competition will also be featured in the ASHRAE Journal.

#### MEMBERSHIP ADVANCEMENT!

Any Associate Member meeting the following requirement can apply for Advancement to the more entitling Member grade. By ASHRAE society definition:

A *member* shall have the equivalent of *twelve society-approved years of experience* composed of an approved combination of: (a) completed education beyond high school, (b) work experience, and (c) professional engineering or related registration or license issued by a legally authorized body.

All technical and scientific education shall be based on curricula approved by the Board of Directors.

Approved engineering curricula shall be equivalent to the accredited by the Accreditation Board of Engineering and Technology in the United States of America or the Canadian Engineering Accreditation Board. Scientific education in fields other than engineering shall be from a college or university course of study that has been accredited by an organization charged with monitoring standards of performance. Society approved years of experience shall be credited as follows:

One and one-half years of credit for each year of completed education for graduates of approved technical curricula. One year of credit for each year of education for non-graduates who have completed a least two years of approved technical curricula. One year of credit for each year of completed education for graduates of colleges or universities which do not have accreditations. Those holding associated degrees from technical institutions shall also be credited for one year for each year of education.

One year for each year of qualifying work experiences in the performance of duties in work related to ASHRAE fields of interest and shall have included research, teaching, design, contracting, engineering sales or engineering management.

Three years of credit for professional registration of license issued by a legally authorized body in engineering or related fields, the requirements of which as to education, examination, and active practice are satisfactory to the Board of Directors.
