Before I start on this month's subject, I would like to thank Pittsburgh Chapter for their hospitality during my recent chapter visit. I would like to especially thank Kurt Scheer and Chris Larry for their time and effort. Pittsburgh is well on its way to hosting the 2006 Chapters Regional Conference (CRC). After an evening of CRC discussion, Board Meeting, and their Monthly Chapter Meeting; a lively informal discussion followed concerning the challenges of chapters today. It was an enjoyable hour or so. So beneficial was that discussion that Charlie and I are planning to host a similar informal session in Baltimore the evening before the Incoming Presidents Workshop. If any of the attendees of Saturday's session want to join us for a similar informal discussion, we will be available (liquid libation may be involved). I invite you to join us Friday Night. I have found that at Society Annual and Winter Meetings, much was accomplished in the informal gatherings. Having the same at the regional level will be beneficial. This is an opportunity, if you want to take advantage. If nothing else you can come in early and have a beer! How can you lose? While I am on the subject of the workshop, we have opened the workshop up to more than the Incoming Presidents so you could have the opportunity to enjoy others company traveling in, the economy of sharing a room, and an additional trained person at the chapter level. We are trying very hard to make it attractive to for you to attend. Let's move on to this month's subject Motivation.

The Random House College Dictionary defines **Motivation** as "the act or instance of motivating". It further explains it as "something that motivates; inducement; or incentive". I'll push it a little further and just say Motivation causes someone to act on or accomplish something. Motivation is something we practice every day. Do you have a child at home? How do you get them to complete their homework or pick up their room? Are you in a management position at work? How do you get employees to complete their work? In ASHRAE we work with volunteers. You don't give them an allowance and you can't put them in time out. You can't terminate them and still accomplish Society's work. A good friend has constantly reminded during my years in ASHRAE leadership, "You can't kill 'em".

If ASHRAE doesn't have volunteers, its work will not be done. Eighty percent of Society's work is accomplished by volunteers. Whether it is just a couple of hours each month or more, we desperately need volunteers to help get the job done. Having said that, do all volunteers accomplish their tasks? Unfortunately, they do not. It is easy for one to raise their hand and say "I'll do that". Completing volunteer work is entirely another matter given all of life's demands and distractions. Not everyone is a self starter. **Motivation** by chapter leaders may be required. As Chapter President it is your job to make sure your chapter personnel complete their tasks. Contrary to some belief, it is not the president's job to do it all. However, it is his responsibility to see the work gets done. Part of the challenge of being President is knowing what work needs to be done. That knowledge can be learned with experience from going thru the chapter chairs. attending Incoming President's Workshops, and attending CRC's. Another challenge is motivating the troops. I do not recommend the General Patton approach with volunteers. First, you can motivate people by example. Give your best to tasks and people around you will follow your example. One of my favorite personal sayings is "Leaders lead, they don't push; that is why it's called Leadership". Second, use recognition; you can **motivate** people by making examples of others who do good work and success is infectious. Third, compliments are one of the best motivators of all. Fourth, nicely remind people that their tasks are due in advance and that you expect them to complete them on time. Pleasant reminders can also be used when deadlines have been missed.

Unfortunately there are those occasions where someone simply cannot be motivated. This is where Society work has been entrusted to one who will not meet his commitment. Failure to motivate some is a disappointment that leaders must endure. You cannot win every challenge. Keep smiling and gain strength from the fact that there are others like you who have accepted leadership positions in ASHRAE and are sharing your pain. If you can get this good at motivating unpaid volunteers, just think how much it will improve your leadership skills at work? ❖

The Society Ballot – A Few Thoughts....

You have recently received a ballot for voting on election of officers and directors, a petition from the hospitality industry, and a bylaws amendment.

The petition requests the development of a separate standard for hospitality facilities. It's obviously your own decision how to vote, but please note that the ASHRAE Board of Directors has strongly recommended that you vote <u>no</u> on this issue. If you, or any of your chapter members, have questions on this item, please feel free to contact me.

The petition is an attempt to side-step the careful ASHRAE process and appeal directly to the Membership. I view this as an abuse of process that sets a bad precedent. The intent of Section 4.3 of the Bylaws (available on the ASHRAE website) is to allow the Board to ask the Membership a question in the form of a referendum. The provision to ask the Membership a question by petition protects the minority when the Board refuses to deal with an issue.

In this case, few issues have had as much discussion by both the Board and its committees. ASHRAE has acted steadfastly and in good faith and the Board has come to a conclusion. If this question were to pass, it would encourage every group that did not like an ASHRAE decision to write a nice sounding petition and bypass the committee, Council, Board review process we have in place.

Points that I feel are pertinent include:

Separate ventilation standards have been created (or are in development) for houses, hospitals, and airplanes. In each case, the proponents for a separate standard made their case to the appropriate bodies from the Project Committee to the Board and ultimately were convincing that there were significant enough qualitative differences to proceed with a separate standard. Others, including the Hospitality Industry, have tried to do the same, but were not persuasive. The issue has been a topic of debate for several years.

The Hospitality industry is requesting special status as a separate occupancy with regards to ventilation requirements. However, the predominant feature that makes the Hospitality industry qualitatively different is the prevalence of smoking. While smoking is surely an issue of significance for that industry, the issue is moot for this petition. The policy of the Society is that our standards do not accommodate any amount of smoking.

There are a host of practical problems that have been considered, but are not mentioned on the ballot, including the difficulty of getting a balanced committee, the need to rectify rates and philosophies between such a new standard and 62.1, etc. The average member could not be expected to

know this, but those in the Society who have the responsibilities have done their due diligence. They have determined that anything reasonable that can be achieved for these occupancies can best be done within the context of Standard 62.1 and not by a new standard.

As a friend commented on this issue, "I would encourage anyone interested to delve deeply into this issue and look at the record of what happened and what would happen. I am confident that those Members who do will make a good decision. For those who do not care to invest that much time, the issue becomes the simpler one of who do you trust more, your Board or a special interest?"

I would add that the number of ballots returned each spring is very small and a few votes could swing the hospitality industry petition vote either way. Regardless of your decision on the issue, please take the time to cast a ballot. Thanks, Charlie. ❖

With monthly data through the end of March, Region III is close to meeting its goal of a delinquency rate of 9%. This is the direct result of all of the hard work performed in contacting delinquents during the month of February. If we continue to follow up, we will break the 9% goal before the end of the year. However, our Regional goal of 12% New Members is in jeopardy, as our current number of New Members is at 5.59%. In addition, we are short of our Advancements goal of 2%, with the Region, which is currently at 0.49%. During the last couple of months of the fiscal year, it is important that we not stop promoting membership, and the benefits ASHRAE has to offer. I therefore challenge each Membership Promotion Chairman to secure at least 5 new chapter members, and 2 new advancements before June 30th. Enlist the help of your Chapter Presidents and board members to ensure that your chapter will be strong long after your term as Membership Promotion Chairman has expired. A healthy sustainable Chapter requires new members, and the only way to obtain new members is to spread the word about the tremendous benefits ASHRAE has to offer.

Remember: Prior Proper Planning Prevents Poor Performance. So plan for the future of your Chapters, and promote ASHRAE Membership. *

Web Site Traces History of HVAC&R Brands

ATLANTA -- Ever wonder what happened to Miller Home Furnace Company? What about Johnson Air-Ease? John Mills did. The service manager for an HVAC&R contractor in Carmel, Ind., has developed a Web page that traces the history of HVAC&R brand names. He says he's not a history buff, and he maintains the site mainly for fun.

"I was just curious where the brands came from," says Mills. "So six or seven years ago I started researching brands for a Web site. Now, I update as needed."

His list now includes more than 90 brands. Some have ceased to exist. But most have been acquired by other companies. For example, Miller Home Furnace Company is now part of Nordyne, while Johnson Air-Ease is part of the Armstrong Air division of Lennox. •

"Money Well Spent"

I know a number of you know about the Milton Garland – Jose Reig Student Challenge and realize that funds are available to support activities that make young people familiar with Heating, Air Conditioning, Ventilation, and Refrigeration. No one in our region makes better use of the program than, past RVC – Student Activities, Dave Meredith. Here is a note from him reporting to Regional Treasurer, Gary Debes on recently "Money Well Spent".

To: Gary Debes From: David Meredith Subject: Milt Garland funds

Just a quick update to let you know how we spent \$900 in Milt Garland funds donated by Region III this year. We actually squeezed three major student activities out of this grant.

- 1. Four students attended the ASHRAE Winter Meeting in Orlando and basically the grant paid for their airfare, while they paid for the rooms two nights and our local fund raising paid for the other two nights.
- 2. Our Girl Power! Program took 17 middle school girls to University Park over Spring Break to tour the Nano Manufacturing Technology clean room. We charged them \$20 each and took about \$200 from the remaining Milt Garland funds to cover the rest of the bus cost.
- 3. Our Engineering Explorer Post for high school students will jump a bus next Tuesday to tour GSA's Central Heating and Cooling plant for the mall area. (As you recall, our original proposal for the Pentagon was rejected due to Homeland Security issues.) This is a new \$30 million CoGen facility with 17,000 Tons of cooling, two gas turbines and 1.6 MM lb/hr of steam capacity. We will eat lunch across the street in the Dept. of Agriculture Cafeteria. Cost to the student is \$20 for this trip as well. Right now we have 20 High School students, 9 college students and 4 parents on the trip. Half of the students are female. I would add that the only graduating senior in the Post plans to attend Penn State in the fall as engineering major.

According to my current estimate, we will have \$12 left in the ASHRAE student account by this time next week. That plus any additional income the rest of the year should be enough for a major end-of-the-year cookout (the way we spend \$\$\$).

I would call that a successful year, and just want to thank Region III again for their support of our activities. I will send a short write-up and photos to Ashley in Student Activities when we get back next week. *

REGIONAL REFRIGERATION ACTIVITIES

Only a few chapters have advised of their Refrigeration activities. If you are reading this article, and say "what about our chapter?" then it is time for your chapter's refrigeration activities to be submitted to Jimmy Carver. All reports must be in by 15 May 2005 to be considered for the Regional *ICEMAN Award*.

Region III members are also encouraged to submit an outstanding refrigeration project to contend for the coveted *Milton Garland Refrigeration Award*. Projects must be submitted by 1 June 2005 to be considered.

Chapter refrigeration programs or articles about refrigeration were presented in several Chapter meetings and Newsletters: Richmond Chapter included an article "Everything About Refrigerants" in its March Newsletter (ASHRAE Reporter). Central Pennsylvania presented a chapter program in February about the unique problems of "Natatorium System Design."

2004-2005 year marks the 100th anniversary of the founding of the American Society of Refrigerating Engineers (ASRE), a predecessor to ASHRAE. Articles cited in recent issues of the ASHRAE Journal include "Case Credits & Return Air Paths for Supermarkets" and "Electronic Expansion Valves" that detail innovative refrigeration engineering.

Refrigeration Pioneer "Gardner Voorhees" was inducted into the ASHRAE "Hall of Fame" at the ASHRAE 2005 Winter Meeting. The Hall of Fame honors deceased members of the Society who have made milestone contributions to the growth of HVAC&R technology. In 1890, Voorhees designed a central refrigeration plant for the Quincy Market Cold Storage Co. and at the St Louis World's Fair he designed a mechanical cooling air conditioning system (the first comfort cooling of a public large building). Voorhees, a charter member of ASRE, died in 1937.

Please consider volunteering your time to review the upcoming Refrigeration Handbook. Your efforts will benefit current and future engineers, with an up to date handbook resource. Region III members are also encouraged to contribute articles to the ASHRAE Journal.

13 APRIL 2005 ASHRAE BROADCAST

The 13 April 2005 satellite broadcast (*Mold in our Building Environment*) was a huge success with participants from over 1500 satellite download sites (and numerous webcast viewers) involved. Six presenters explored prevention of mold in new construction, methods for monitoring mold in indoor environments, detection of biological contaminants, solutions to prevent and/or alleviate mold problems and the legal issues relating to mold contamination. A CD on that broadcast is currently available through ASHRAE for a nominal cost. If your chapter participated by hosting a Satellite Broadcast reception for your members, please be sure to claim your 100 PAOE points.

PAOE UPDATE

As of 14 April 2005, all but one chapter have now entered PAOE points in the CTTC category. However, these points appear inadequate compared against the extensive activities that we know are being undertaken by various chapters in the program, refrigeration, and TEGA sectors. All CTTC chairs are encouraged to log onto the ASHRAE website and update PAOE points for **completed** chapter activities.

Congratulations to the *National Capital* and the *Richmond* Chapters for reaching PAR (i.e., 750 points). Additionally, the *Anthracite* Chapter has reached MINIMUM (i.e., 350 points).

All chapters are reminded that the CTT Committee is a *mandatory standing committee* and that in the upcoming societal year each chapter **must** assign a responsible person to chair its CTT Committee.
